

Annexure "A"

PROPOSAL FOR CHANGE OF VACATION, ADMISSION AND  
EXAMINATION SCHEDULE IN RESPECT OF COLLEGES IN THE STATE  
for 2016-17

For Semester System (1<sup>st</sup> year Class) .....in phased manner....

The Semester System has been introduced in the Colleges of Himachal Pradesh from the 1<sup>st</sup> year of degree courses from the session 2013-14. In view of this, the proposed admission/vacation/examination schedule for the academic session 2016-17 is as under: -

Admission Schedule			
Sr.No.	Period	Days	Remarks
1.	21 <sup>st</sup> June to 25 <sup>th</sup> June, 2016 (Earlier it was 11 <sup>th</sup> June to 20 <sup>th</sup> June)	05 days (Earlier it was 10 days)	Submission of Admission forms by the Students
2.	26 <sup>th</sup> and 27 <sup>th</sup> June, 2016	2 days	Display of merit list
3.	28 <sup>th</sup> - 30 <sup>th</sup> June, 2016	3 Days	Fee Deposit by the students

Note:- It will be mandatory for every college to display time table giving all the details about Major/Minor/Elective subjects etc. in the 1<sup>st</sup> week itself after the closure of all admissions i.e. 1<sup>st</sup> July itself, so that the students can choose their minor/elective/GI&H subjects as per the time table and this week will be called as Zero Week.

- The regular teaching to classes of I/III and V Semester will commence from 1<sup>st</sup> July, 2016 to 14<sup>th</sup> October, 2016 i.e. 15 weeks.
- End Semester Examination (Practical/ Theory) of I/III and V Semester will commence from 15<sup>th</sup> October, 2016 to 14<sup>th</sup> November, 2016 = 30 Days.
- Evaluation of I/III and V Semester examination 15<sup>th</sup> November, 2016 to 23<sup>rd</sup> November, 2016 = 9 Days.
- II/ IV and VI Semester regular teaching starts w.e.f.
- 24<sup>th</sup> November, 2016 to 31<sup>st</sup> December, 2016 = 38 Days
- 11<sup>th</sup> February, 2017 to 28<sup>th</sup> February, 2017 = 18 days
- 1<sup>st</sup> March, 2017 to 14<sup>th</sup> April, 2017 = 45 Days
- Total = 101 Days
- End Semester Examination (Practical/ Theory) of II/ IV and VI Semester 15<sup>th</sup> April, 2017 to 20<sup>th</sup> May, 2017 = 36 Days.
- Evaluation of II/ IV and VI Semester examination 21<sup>st</sup> May, 2017 onwards till 31<sup>st</sup> May, 2017.



## Annexure "B"

Vacation Schedule

Sr. No.	Period	Days	Remarks
1.	1 <sup>st</sup> June, 2016 to 20 <sup>th</sup> June, 2016	20 days	In all Winter/ Summer closing Colleges.
2.	Diwali Break 28 <sup>th</sup> October, 2016 to 31 <sup>st</sup> October, 2016	4 days	In all Winter/ Summer closing colleges.
3	1 <sup>st</sup> January, 2017 to 10 <sup>th</sup> February, 2017	41 days	In all Winter/ Summer closing Colleges.

Note: - Admission is open for all students on Roll on Basis, who are otherwise eligible without waiting for the final result. Roll On system means the student who has appeared in the 1<sup>st</sup>/3<sup>rd</sup> & 5<sup>th</sup> Semester will go to the 2<sup>nd</sup>/ 4<sup>th</sup> & 6<sup>th</sup> Semester as per the schedule without waiting for the result of the 1<sup>st</sup>/3<sup>rd</sup> & 5<sup>th</sup> Semester. However, he/she will have to fulfill all the formalities laid down by the college authorities like filling up of the admission form, if any, and depositing the prescribed fees. This will help to start the regular teaching of 2<sup>nd</sup>/4<sup>th</sup> & 6<sup>th</sup> Semester in time.

Principal may ensure that there is no provision of admission as per university ordinance after 30<sup>th</sup> June of every year and as per Hon'ble High Court Decision, no admission will be given after the schedule. Principal concerned will be responsible for strict compliance of the admission schedule.
